**Eligibility:** Open to all artists, 18 years and older. Artists may submit up to three original, two-dimensional pieces of work, fine art, or photography created in the last three years and not previously shown in WAA shows. Craft items or nudes will not be accepted. Any questions, please contact info2019@willingboroart.org

Work must be framed safely and wired for hanging, no clip frames. Gallery wrap canvas is acceptable (no visible staples).

**Maximum size:** 40" in all directions, including frame.  
Weight limit: 15 lbs.

**Commission & Sales:** The Gallery of the Virtua Health Foundation will receive a 30% commission. Payments will be made directly to the **Gallery Credit Union Office** (located next to the gallery). The Gallery will furnish the artists with an accounting within 30 (thirty) days after the close of the exhibition. No additional WAA commission.

**Loss & Damage:** The Gallery shall not be responsible for the safekeeping of all consigned artwork and will not be liable for loss or damage.

**Delivery/Removal:** Work will be delivered on site and may not be removed prior to the end of the exhibit.

**Entry Fees:** (non-refundable) May submit up to 3 pieces.

Member 1 - \$15. 2 - \$20. 3 - \$25  
Non-Member 1 - \$25. 2 - \$30. 3 - \$35

**Registration:** Fill-out and bring this form with payment, cash or a check (payable to Willingboro Art Alliance), at intake. Fill out the Artist's Receipt and WAA form and attach labels to the artwork. WAA will assign item #s at intake.
